- Send the completed form to the AQA Chair for review.
 - The Chair will confirm that none of the selected reviewers have been used in reviews outside of your faculty.
 - Contact External Reviews only once the AQA Chair has confirmed that reviewers have not been used for ULeth AQA reviews.
 - The Dean's office is responsible for contacting the individuals on the list to secure the services of two (or more if required) External Reviewers.
